Walnut Grove Campground Rules

1. Organized group camping is not permitted in the family campground but is permitted at the designated Group Camp.
2. A single camping stay may not exceed fourteen (14) consecutive days. All campers must vacate the campground for at least five days if the 14-day maximum has been reached before the next camping stay can begin.
3. Cancellations made at least 24 hours prior to the arrival date will receive a refund less one-night fee (\$25).
4. Lower Huron Metropark Campsites are limited to one (1) camping vehicle (motor home, travel trailer, pop-up camper, truck camper) and one non-camping vehicle (car, van, pickup) and two (2) tents or canopies per site.
5. Camping (or sleeping) in an automobile, truck or on the ground outside is prohibited.
6. Campsites are limited to eight (8) campers per site.
7. Check-in time is 1:00 p.m. Campers must check out by 11 a.m. on the date of their departure. Additional days fee will be applied to late checkouts.
8. Campers must be eighteen (18) years of age, or older, to register for a campsite. The registrant is responsible for the conduct of their camping companions, guests and visitors to their campsite.
9. Visitors of registered campers must pay the appropriate vehicle entry fees and park in the parking lot adjacent to the campground. All visitors must vacate the park by 10 p.m.
10. Campers must observe quiet hours between 10 p.m. and 7 a.m.
11. Generators are permitted however may not be used during the quiet hours of 10 p.m. to 7 a.m.
12. Never leave pets unattended and must be on a 6-foot leash. Please clean up after your pet.
13. Ground fires are permitted only within the provided fire rings.
14. Campfires are not to be left unattended. Fires must be extinguished before retiring for the evening or upon departing the campsite.
15. Cutting of trees and/or the collection of downed wood is prohibited. Wood is available for purchase.
16. Please clean campsite and deposit all trash in the trash receptacles prior to departure.
17. Abusive behavior or conduct that may endanger the welfare of any person is strictly prohibited.
18. Vehicle Entry Fees-Metropark vehicle entry permits are required on all motor vehicles which enter the Metropark. Park entry fees are not included in the reservation fee.
19. Please be aware that all park gates will be locked between the hours of 10 p.m. and 6 a.m. Contact the Park Police at the number provided below for EMERGENCY exit or entrance. For emergency assistance after posted Park Office Hours please call 810-360-7695
